Wilson's Comments:

Monday I attended the Law Board meeting, where the biggest item was an executive session for Director Schoen's annual review.

Tuesday I attended the Chamber of Commerce monthly board meeting, this time hosted at the Biosecurity Research Institute at K-State and featuring an interesting presentation about the BRI.

Wednesday I attended the Metropolitan Planning Organization and Regional Transit Administration board meetings. In the MPO meeting we finalized transitioning our fiscal agent from the Flint Hills Regional Council, which naturally suffers cash flow issues, to the City of Manhattan. The MPO will still remain independent of the city, we will just be contracting with them for financial processing, and that at a lower rate than we were paying the FHRC. We were also updated that KDOT approved our requests for access to state and federal funding for K-99 improvements between Wamego and I-70 and for IT infrastructure improvements along K-18 between Manhattan and I-70 that will provide better connectivity and traffic data sharing with Fort Riley and Junction City. In the RTA meeting we discussed spending on security projects. One of the strings attached to the federal transit funds we manage, is that at least 1% of the money each year has to be spent on transit-related security projects. This is a challenge and inefficiency for a low-crime region like ours. Like last year, our security projects this year have focused on additional security at the ATA Bus facility at the county shop site north of town.

Attended the ATA board meeting on Tuesday evening the 19<sup>th</sup>. Spoke to several individuals by phone and then went Christmas shopping.

Wells' Comments:

Wells said he attended the North Central Kansas Regional Juvenile Facility meeting. Wells discussed the success of the North Central Kansas Regional Juvenile Facility, which serves fifteen counties.
